MINUTES MEETING

IMPLEMENTATION COMMITTEE OF THE MAHE PLATEAU TRAP AND LINE FISHERY CO-MANAGEMENT PLAN

SFA Conference Room, Providence Wednesday 30 January 2019 10:00 A.M.

Introductory Remarks

The first meeting of the Implementation Committee for the Co-Management Plan of the Mahe Plateau demersal trap and line fishery was held at Providence at the Seychelles Fishing Authority Conference Room, Seychelles, on the 30th January 2019.

Opening and background to the Meeting

Mr. Calvin Gerry, Deputy CEO, SFA, welcomed the participants of the meeting and explained the reasons for delays in Implementation. He transmitted apologies on behalf of the PS of MFAg and the CEO, SFA for not being present.

Mr Vincent Lucas, CFO, SFA gave a brief history about the process for developing the plan.

1.0. Adoption of the agenda

As currently there was yet to be an elected chairperson, the Deputy CEO of SFA had the task of chairing the meeting.

The agenda was adopted and is presented in Appendix 1. The list of participants is presented in Appendix 2.

2 Rules of procedures of the Implementing Committee

The consultant, Mr. Harris, presented a working paper on terms of reference of the implementation Committee of the Mahe Plateau Trap and Line fishery Co-management Plan. He recalled the concept of co-management from the Fisheries Act of 2014, elaborated on the requirement of working in close collaboration, explained the nature of the proposed implementation committee of primary and secondary stakeholders as a co-management

structure and its possible lines of reporting. The setting up of the implementation committee was a recommendation from the stakeholders during the development of the plan and was endorsed by the cabinet of Ministers when it approved the implementation of phases one and two of the co-management plan in August 2017. FBOA's comments on the plan would be considered at the next meeting.

2.1 The Rules and procedures of the Plan.

The Chairperson proceeded to examine the Rules of Procedure of the implementation Committee assisted by the SFA Secretariat. The Rules of Procedure with changes and insertions made by stakeholders during the meeting is presented in Appendix 3.

2.2 Election of Officers and consideration of the Membership

The meeting agreed to defer the Election of Officers to the next meeting. It considered the membership of the Implementation Committee and agreed on the list presented in Appendix 4.

Other Matters

During the meeting, the importance of the participation of fisher associations was raised as well as the possibility of a meeting allowance. The meeting considered that a meeting allowance was not in keeping with a good co-management practice, as members would be seen as being paid to represent their own interests. Nevertheless, the meeting recognised that fisher associations need support and capacity building which is a matter that would be covered within the actions proposed by the co-management plan proper.

Stakeholders expressed dissatisfaction that the 1st Implementation Committee meeting was not attended by a representative from the MFAg. They looked forward to active participation of the MFAg at the next and subsequent Implementation Committee meetings.

Date and Place of the next meeting

The meeting left it to the Secretariat to determine the date and place of the next meeting. This is proposed to take place on Wednesday 6th March 2017 at the SFA Meeting Room, Fishing Port.
