This report was prepared by **Mr Jude Bijoux** from September – December 2021. Mr Bijoux was appointed by Seychelles' FiTI National Multi-Stakeholder Group as the Report Compiler for the 2020 FiTI reporting process. The report was reviewed and approved by **Seychelles' FiTI National Multi-Stakeholder Group** on 6th December 2021.

This is Seychelles' second report to the FiTI, covering information relevant for the calendar year 2020. This report, hereafter referred to as Seychelles' 2020 FiTI Report, has been divided into **two distinct sections**: a 'Summary Section', which provides a high-level overview of the transparency assessment's key findings, and this present 'Detailed Section', which delves into greater detail according to each of the FiTI Standard's 12 transparency requirements. This detailed section also includes information relevant for 2020 which has only been published as part of this FiTI Report.

The report was funded by the **Third South West Indian Ocean Fisheries Governance and Shared Growth Project** (SWIOFish3) through a Global Environment Facility grant (TF-A5293) administered by the International Bank for Reconstruction and Development (IBRD).



Detailed findings on the requirements for fisheries transparency in Seychelles [2020]

The need for governments to share information on fisheries is already described in the 1982 United Nations Convention on the Law of the Sea and the FAO's subsequent Code of Conduct for Responsible Fisheries. Since then, the importance of collating and sharing information with all stakeholders has been a message conveyed in other landmark documents on fisheries reforms.¹

The FiTI provides a unique global framework (i.e. the FiTI Standard) to help coastal countries to increase the credibility and quality of national fisheries information and demonstrate their commitment to improving fisheries governance.

The FiTI Standard covers 12 thematic areas of fisheries management (also referred to as transparency requirements) and is applicable to all countries.

The FiTI does not intend to replace or duplicate existing government websites, but rather supports the continued development and maintenance of these public resources.

Major legislations and policies for Seychelles' fisheries sector:

The *Fisheries Act (2014)* is the primary legislation governing the fisheries sector of Seychelles. The Act provides for the management and sustainable development of the fisheries sector, and makes provision for the licensing of fishing vessels, the regulation and enforcement of fishing and fishing-related activities and caters for offences with regards to the breach of its provisions.

The *Fisheries Regulations (1987)* is the main piece of secondary legislation. Amongst other things, it covers the conditions for issuing of local fishing licences, establishes management measures for certain fisheries and covers marking of vessels and gears.

The *Fisheries Sector Policy and Strategy (2019)* is the primary policy document for Seychelles' fisheries sector. Its primary objective is to provide the principles for the implementation of the vision of Seychelles' fisheries sector, namely to '*develop fisheries to its full potential whilst safeguarding the marine environment and resource base for sustainability*.'

The *Fisheries Comprehensive Plan (2019)* is a document developed to guide future actions and spearhead the development of the fisheries sector up to the year 2021.

According to the National MSG, the Government of Seychelles have met all of the requirements of FiTI concerning the publication of an online and up-to date registry of national legislations, policy documents related to the marine fisheries sector. The National MSG encourage the national authorities to keep this information up to date and frequently raise awareness of the public and operators in the fisheries sector on the policies and legal requirements in place for different fisheries sub-sectors.

Fisheries laws and regulations: The website of the MOFBE now has a section dedicated to fisheries laws and regulations². In addition, MOFBE has published the Access to Information Act (2018)³ on its website, which sets clear transparency standards for

making information accessible to the public. All those documents relevant for year 2020 are published on the website of the MOFBE and this document list is *seen as complete*. The SFA website also publishes key pieces of fisheries legislation⁴.

Fisheries policy documents: The website of the MOFBE now has a section dedicated to fisheries policy documents and management plans.⁵ The fisheries policies published by the government that are publicly available online for the year 2020 are *seen to be complete*. In addition, SFA has published a summary of the organisation's strategic plan 2018-2020. The only known management plan (though not a fishery management plan) under implementation in 2020 that the National MSG noted as absent from government websites is the Seychelles Drifting Fish Aggregating Device Management Plan 2020-2021, submitted to the IOTC in August 2020 and which is available for download from the IOTC website⁶.

- **Online registry of national laws and regulations:** The website of the Office of the 0 Attorney General has a page dedicated to the 'Laws of Seychelles' where Acts are available for download⁷. However, the published 'Laws of Seychelles' page is the 2010 edition and still features the Fisheries Act of 1986, rather than the updated Fisheries Act of 2014. The website has a link to the Official Gazette, but the page is not populated. In 2020, the Office of the Attorney General launched a separate website for the online publication of the Official Gazette⁸. At the time of preparation of this report, the website contained Gazettes only for the year 2019 and 2021. A note states that the website will only contain Gazettes that were published within the last 5 years. An email address is provided for requesting digital copies of Gazettes published before 2015. An administrative fee of SCR 25 has to be paid for this service, with an additional fee of SCR 50 if requesting a certified copy by the Attorney General or the Editor. The eDoc Repository on the eGovernment Portal⁹ has the required infrastructure for providing access to laws and regulations and a section dedicated to 'Acts and Regulations'. It appears that the eDoc Repository is being used, at least by certain government agencies, with evidence of new documents uploaded. However, the 'Acts and Regulations' related to fisheries are still not featured.
- National Assembly documents: Access to bills that are introduced to the National Assembly of Seychelles (NAS) for examination, discussion and amendment are obtainable

through the NAS's official website¹⁰ along with videos of all sittings of the NAS and public hearings of certain assembly committees, starting from 27th September 2016. These online videos can be used for background research and verification of facts of what was said during debates concerning introduction and amendments to fisheries laws and regulations.

International treaties, policy instruments and best practices: MOFBE as well as SFA have published on their websites the list of major international fisheries and fisheries-related instruments and treaties that Seychelles is party to or abiding to.

The main treaties found to be missing are the Regional Fisheries Management Agreements such as that relating to the formation of the IOTC¹¹, the SWIOFC¹² and SWIOFA,¹³ and links to summaries of conservation management measures in place under the SWIOFC and SWIOFA agreements. The National MSG took note that publishing these international instruments is not a requirement of the FiTI Standard.

In November 2021, SFA posted on its website a Frequently Asked Question (FAQ) section, providing responses to a wide range of questions that members of the public might have about tenure arrangements in Seychelles' fisheries. The FAQ presents the information in a user-friendly format and, inter alia, includes descriptions of the rights and authorisations applicable by law or decree to each fishery, as well as information on the access to and use of traditional

sites, for landing fish, for temporary fish camps, and for other traditional uses¹⁴. This fulfils recommendation 2019-2_1 from the 2019 FiTI report, which urged SFA to publish a summary description of the different types of fisheries that exist in Seychelles, and their corresponding licence arrangements.

The information on fisheries tenure arrangement is *seen as complete* by the National MSG. It is however to be noted that the processes and procedures for issuing of new licences for joining the sea cucumber fishery are still not publicly available. The National MSG further noted that recommendation 2019-2_2 which states that *MOFBE should publish in the Official Gazette the fees that need to be paid for all types of fisheries rights existing under the law (also including changes to current fee structures)* has not been implemented due to time constraints. SFA indicates that this will be implemented during the year 2022.

- The persons legally entitled to issue access rights and fishing authorisations: The National MSG found no publications from Seychellois authorities pertaining to individual persons that are legally entitled to issue commercial access rights and fishing authorisations. SFA is the legal authority mandated to issue licences for fishing and fishing-related activities, as per Part III Licensing Requirement of the 2014 Fisheries Act, excluding processing of fin fish. The Fisheries Act does not specify that the names of the persons legally authorised to issue licences and permits have to be published¹⁵. The National MSG noted that SFA can authorise for any of its staff to issue such permits and authorisations¹⁶. The National MSG considers this a good arrangement as staff turnover can be quite high in Seychelles. The National MSG further noted that the Fisheries Act does not make it mandatory for SFA to publish details of the fishing licences and permits it issues, and that SFA has gone the extra mile to publish such information through the 2020 large-scale vessel registry¹⁷ and the issued documents on small-scale fisheries licences¹⁸.
- Other conditions applicable to commercial fishing rights: Conditions applicable to fishing rights are prescribed in Part III of the Fisheries Act (2014), as well as under the Standard Requirements of the Fisheries Regulations (1987). In the following, several key conditions are further elaborated:
 - *Transshipment and catch reporting:* There are no specific conditions concerning transshipment and catch reporting for any local fishing licences, except for the

lobster fishery¹⁹. However, Article 7(2) of the Fisheries Act makes it a requirement for those engaged in fishing and fishing-related activities to provide information regarding their activities (including catch, effort, fishing locations, landing and transshipment) to SFA when requested.

- *Fishing effort:* Only the sea cucumber fishing licences restrict the number of fishers (divers in this case). This also stipulates the opening and closing date for the sea cucumber fishing season. Licence conditions for the net fishery restrict fishing to daytime, between 6 a.m. to 4 p.m.
- Landings: All vessels licenced to fish in Seychelles' waters are obliged to land all catches made in Seychelles' waters in Port Victoria or designated landing sites, except if otherwise authorised by SFA. Landings of catches made in Seychelles' waters in foreign ports require permission from SFA.
- *Ecosystem impacts of fishing:* There are no conditions that specifically relate to ecosystem impacts. However, the prohibited use of unauthorised gears as per Section 32(2) of the Fisheries Act, and restrictions in the use of Fish Aggregating Devices (FADs) as per Section 33, directly address such impacts. The Fisheries Act does however provide scope for authorities to put in place new conditions for issuing of fishing authorisations to further control fishing efforts, reduce ecosystem impacts of fishing and to improve landings, transshipping and catch reporting.

For the small-scale fisheries (i.e. artisanal and semi-industrial longline), the extract of relevant licensing conditions is published in the Fisheries Comprehensive Plan. The Plan also lists the current licence conditions for net fishing²⁰ (separate conditions for mackerel and sardines), sea cucumber, and lobster fishing, and for the processing of sea cucumbers. Furthermore, small-scale fishing vessels (those with autonomous power supply) need to have their Vessel Monitoring System (VMS) operational throughout the whole trip, in order to be entitled to fuel concessions (see Section 2.10 of this FiTI Report).

- Oversight and public consultation processes: This FiTI reporting process found no published summary descriptions detailing the nature of any oversight or public consultation processes involved with respect to fisheries tenure arrangements in 2020.
 - For *local commercial fishing licences* (as well as *sport fishing licences*), oversight requirements are listed as part of Section 17 and Section 18(5) of the Fisheries Act.

• For *foreign commercial fishing licences*, oversight requirements are listed under Section 11 and 12 of the Act. Oversight for issuing such licences usually takes the form of ensuring the vessel does not feature on the list of vessels presumed to have conducted IUU fishing in the IOTC Area of Competence.

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding fisheries tenure arrangements in Seychelles:

Foreign fishing access agreements (and evaluations): In 2020, Seychelles had four agreements allowing foreign vessels to fish in its waters, and two agreements allowing Seychelles-flagged vessels to fish in third country's waters. Foreign fishing vessels from Dongwon Industries Co. Ltd fish in Seychelles' waters in the absence of an agreement through the payment of a licence²³.

As part of this reporting process, all agreements have been published on the SFA website^{24,25}, except those (private) agreements where confidentiality prevents such a publication.

The current agreements with TTA and TFI both contain articles which prevent Seychelles from divulging their contents without the prior knowledge and written approval of the other party. At the time of finalisation of this FiTI Report, the Seychelles' government was renegotiating both agreements and had pledged to remove such confidentiality clauses

For each of the agreements active in 2020, key information has been summarised in a tabular form in Annex C.

It is emphasised that neither of these reports (nor any other known report) have assessed the compliance levels with the terms and conditions of the fisheries agreements.

A more detailed report, namely the 'Ex-post and ex-ante evaluation study of the fisheries partnership agreement between the European Union and the Republic of Seychelles and of its implementing protocol was commissioned by the European Union in 2019. The report provides an analysis of Seychelles' fisheries sector and financial analysis of various aspects of the Sustainable Fisheries Partnership Agreement. During the process of preparing this FiTI report, this report was published on the website of the SFA.

[Best available information] The National MSG found no instances relating to the assessments of the impact of these foreign fishing access agreements, where information used by national authorities is clearly misleading, or could be improved by considering alternative sources of information, such as studies by non-governmental organisations, the private sector or academic institutions.

Stakeholder consultation: No documentation derived from national stakeholder consultations regarding the preparation, negotiation or monitoring of foreign agreements was collated or published by the government of Seychelles in 2020. That year, Seychelles negotiated the new Sustainable Fisheries Partnership Agreement (2020 – 2026) with the European Union. All discussions undertaken prior to renegotiation and signing of this agreement were done primarily within the government, through the involvement of different governmental ministries and agencies. No minutes of these discussions have been published to date. The agreement and adjoining protocol were ratified by the National Assembly in June 2020, after extensive debate with 28 of the 34 members voting in favour.

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding foreign fishing access agreements:

The National MSG acknowledges the importance of information on stock status and noted the presence of a stock status summary (published on the SFA website²⁸) of fish species that have been assessed within the last four years. This fulfils recommendation 2019-4_1 of the 2019 FiTI Report.

The stock status summary contains hyperlinks to individual stock assessment reports for all but one of the species concerned²⁹. Details of the methods used to undertake the stock assessments are available as part of these more comprehensive reports.

In 2020, only one stock assessment report was produced by SFA. This was for the commercially exploited spiny lobsters. On the other hand, in 2020, the IOTC provided a stock information update for the majority of species under its management³⁰. A summary of the IOTC update is also included in the stock status summary published by SFA.

A graphical overview of the stock status summary is provided in the summary section of this 2020 FITI Report. In short, of the 32 species for which stock status updates are available, 12 are considered *overfished*, of which 8 were also classified as *subject to overfishing*. Two species were classified as subject to overfishing but not overfished, while four species were classified as overfished but with uncertain stock biomass status.

To facilitate public understanding, the National MSG provides details on the status of species whose stocks were updated via new assessments conducted in 2020:

- Lobster: Stock status reports were produced in 2019³¹ and 2020³² based on annual surveys and are published on the SFA website. The 2020 report based on the fishery independent Participatory Lobster Monitoring Programme (PLMP) recorded an increase in Catch Per Unit Effort (CPUE) and increase in relative abundance and biomass of all lobsters species caught, with a noted increase in the relative abundance and biomass of legal-size lobsters (more than 7.5 cm carapace length). The data is supported by CPUE data from the fishery. The 2020 spiny lobster stock status report made the following key recommendations: (i) that the fishery be opened for a three-month period over 2020-2021, (ii) the number of licences be capped at 16, and (iii) monitoring, control and surveillance is strengthened to discourage illegal fishing activities during opened and closed fishing season. A summary report providing details of the 2020/2021 lobster fishing season was published online by SFA during this FiTI reporting process³³.
- Tuna and tuna-like species: Assessments of tuna and tuna-like species targeted by the industrial longline and purse seine fishery are not undertaken by the government of Seychelles, but by the IOTC. Seychelles contributes to these stock assessments through the provision of sampling data collected during landings and transshipments. Stock status determination for 2020, based on the 2018 assessment, indicates very high probability that the stock of Yellowfin tuna (*Thunnus albacares*) is *overfished and is subject to overfishing*, while the stock assessment undertaken in 2019 shows high probability that the stock of Albacore (*Thunnus alalunga*) and Big eye (*Thunnus obesus*) are *not overfished* but *subject to overfishing*, while the stock of Skipjack (*Katsuwonus pelamis*) is neither overfished nor subject to overfishing.

For Billfish, the IOTC 2020 stock status determination, based on 2017 and 2018 assessments respectively, indicated that stocks of Blue Marlin (*Makaira nigricans*) and Striped Marlin (*Tetrapturus audax*) were *overfished and subject to overfishing*. In 2020, the stock status of both the Black Marlin (*Makaira indica*) and Swordfish (*Xiphias gladius*) were classified as *not overfished* and *not subject to overfishing*, based on the 2018 stock assessment, while the biomass and fishing mortality of the Indo-Pacific sailfish (*Istiophorus platypterus*) could not be assessed and was determined to be *uncertain*. The stock assessment report highlighted the continued increase in catches for this species as a cause of concern.

The National MSG notes that, as part of this FiTI reporting process, SFA published its work programme for future stock assessments up to the year 2024, fulfilling recommendation

 $2019-4_3$ of the 2019 FiTI Report. The work programme also provides a link to the IOTC schedule of future stock assessments up to 2023^{34} .

[Best available information] The National MSG found no instances relating to the state of fisheries resources, where information used by national authorities is clearly misleading, or could be improved by considering alternative sources of information, such as studies by non-governmental organisations, the private sector or academic institutions.

Recommendations

The National MSG took note that as part of this FiTI reporting process SFA published an industrial vessel registry in an Excel format on its website with fields for all vessel attributes as required by the FiTI Standard as well as licence payments made by vessel operators or their agents. The number and types of industrial vessels from the registry is summarised in the table below according to flag state.

The National MSG also noted a second source of information on the industrial fishing vessels that were operating in Seychelles waters in 2020 in the form of the Semester 1 (2020) Fisheries Statistical Report. Three discrepancies³⁵ are noted between these two different data sources. Firstly, inconsistent numbers of Seychelles-flagged supply vessels and Seychelles-flagged longliners are recorded in the 2020 Vessel Registry on the SFA website and in the Semester 1 (2020) Fisheries Statistical Report. Similarly, the same registry and statistical report again contain differences in terms of the numbers of Taiwan (POC)-flagged longliners. The data published in the 2020 Vessel Registry is seen as being accurate.

Based on the verification of 180 vessel records within the SFA-internal registry, the National MSG made the following additional observations:

i. *The legal owner of the vessel and their address and nationality:* The section containing details of the company that owns the vessel that had been licenced to fish was filled in all

cases. The National MSG was however unsure if the information given accurately reflected the actual legal owner of the vessel and their address (instead of that of their agent) in all cases. Also, information on the legal owner of the licenced vessels does not include nationality. It is therefore not possible to compare the licensed large-scale vessels according to their flag State with their legal ownership. It was noted that the reporting of Seychelles-flagged large-scale fishing vessels might confuse the general public, which could misinterpret this with ownership. Furthermore, SFA does not clearly indicate the beneficial owner of the vessel – and while not required by the FiTI Standard – this is a clear contradiction to Paragraph 8(2)(r) of the Fisheries Act which states 'the Record of fishing vessels shall contain the name, address and nationality of any person with beneficial ownership of the fishing vessel.'

- ii. *Physical characteristics:* Of the 180 vessels whose records were available for verification, the following number had details of the physical characteristics of the vessels:
 - Vessel length: 180
 - Vessel width: 180
 - Gross tonnage: 180
 - Engine (type) and power: (147) 99
- iii. Fishing agents: Of the 180 vessels, the 176 foreign-owned licenced vessels had record of their local agent.³⁶ This is a requirement as per Section 11(6a) of the Fisheries Act. The other four vessels were locally owned and are not required to have a local agent. From the list of 176 foreign-owned licenced vessels, 174 had record of the vessel's foreign agent (though is not a requirement of the FiTI Standard).
- iv. Quantity and names of target species, permissible by-catch and discards: All licenced vessels were authorised to target tuna and tuna-like species. For the year 2020, the available quota of yellowfin tuna for Seychelles-flagged purse seiners was distributed equally among vessels, with each purse seine assigned a quota of 2,555 Mt. Seychelles-flagged industrial longliners were each assigned a quota of 50 Mt in order to account for fishing in excess of the available quota for industrial longliners in 2018 and 2019.
- v. Country and/or regions of the High Seas where fishing is authorised: This information is relevant only for Seychelles-flagged vessels. In 2020, 80 Seychelles-flagged large-scale vessels were granted authorization to fish on the High Seas and in other countries EEZ, including 61 vessels licenced in 2020 and 19 vessels licenced in 2019 which licence remained valid in part of 2020.



Given the economic importance of fisheries for Seychelles, the National MSG has outlined this simplified illustration of the various direct revenue sources provided to government by large-scale fishing vessels:



During this FiTI reporting process, SFA published online the licence payments made by largescale fishing vessel operators allowing them to fish in Seychelles' waters in calendar year 2020. This information is published as part of the large-scale vessel registry and is available on the SFA website³⁷.

An analysis of data found in the large-scale fishing vessel registry by the National MSG took note of the following points concerning payment for fishing:

- Complete licence payment information was available for all the 180 vessels that featured on the vessel registry. The purpose of the payment was identified in all cases as licence fees and the information was followed by the name of the vessel and the SFA-assigned vessel number.
- Two Taiwan (POC)-flagged longline vessels (SHYANG CHYANG NO.888 and SI CHUEN NO.212) identified on the vessel registry had been issued a half-year and annual licence respectively but there was no evidence of payment in the SFA records. SFA feedback indicates that the licence payment received for vessel LU QING YUAN YU 106 was subsequently transferred to SHYANG CHYANG NO.888, as the former vessel developed mechanical issues and so could (and did) not fish. SFA explained that the licence payment for SI CHUEN No. 212 was received in 2019 as the licence started on 18/01/2020.
- In the case of the four industrial longliners OCEANA 1, OCEAN 2, OCEAN 3 and OCEAN 5, one-year licence was purchased for each vessel, at a fee of USD 17,500 (from 10/12/2020 to 09/12/2021). According to the Fisheries Comprehensive Plan, a half-year licence fee for locally-flagged industrial longline vessels should be USD 17,500, while a one-year licence fee should range from between USD 20,125 to USD 24,000. It therefore appears that these vessels were given a preferential rate. SFA indicates that this special fee for joint venture vessels came through a board directive, after a request was made by the boat owners. SFA has not been able to provide official documents detailing this decision.
- In the case of the Seychelles-flagged purse seiner INTERTUNA TRES, there should have been payment of a second instalment in December 2020, but this did not feature in the

SFA licence payment records for the year 2020. *SFA confirmed that the payment was only received in February 2021.*

- In only one instance was the assigned number wrongly recorded, however the name of the vessel was correctly recorded. This related to the longliner FULL ALWAYS 168.
- Information on the *natural person or legal entity making payments* for large-scale fishing activities in Seychelles' waters has been erroneously collated by SFA. Instead of recording the name of the companies (usually the vessel foreign agent) making the payment for licence fees in their accounting software, the name of the vessel's local agent, to which receipts are sent, is recorded. There were indeed some cases when payments were made by the local agents. However, in the majority of cases, payments came directly from the vessel operators or the association of vessel owners.
- Name of the national authority who received the payment: In the majority of instances, payments were received through the Central Bank of Seychelles (CBS), which notifies SFA. SFA then has to provide relevant documentation (swift transfer notification from the company making the payment and licence application details) before the CBS transfers the fund to SFA account. In a small number of cases, payments were made directly into SFA's bank account.
- The purpose of the payment: The Accounts Section of SFA keeps a record of the purpose of payments made by vessels for fishing activities. The National MSG was able to verify the vast majority of licence payments made for the year 2020. Details are included together with the large-scale vessel registry.

Payments of *excess catch* cannot be published on a per vessel basis for EU vessels as per the terms of the EU/Seychelles Sustainable Fisheries Partnership Agreement. *Port fees* are also not available on a per vessel basis to the fisheries authorities, as they reside with the Seychelles Port Authority – only aggregated data is transferred to SFA.³⁸

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding payments from large-scale vessels for fishing activities:

Catches of Seychelles-flagged vessels: Data on retained catches of active Seychelles-flagged large-scale fishing vessels for 2020 is available online, published in the Semester 1 Fisheries Statistical Report (2020)³⁹. The available catch data is summarised below, disaggregated by species and geographical areas.⁴⁰

However, the data is incomplete. While catch data from all Seychelles-flagged purse seiners is provided for the entire calendar year 2020 based on 100% logbook return and is *perceived as nearly complete*,

- catches from the industrial longline fishery during Semester 2 (July December 2020) is completely missing⁴¹, and
- catches from the industrial longline fishery for Semester 1 (January June 2020) is based only on 82% logbook returns. Logbook return from the industrial longline fishery has never reached 100% and SFA does not extrapolate the catch data – and as a result have historically underestimated the catch. SFA cites the level of complexity involved in accurately estimating catch data as the main reason for not extrapolating catch data for this fishery. SFA also informed the National MSG that 2020 was the first time they have received 100% log book return from the industrial longline fishery and that the published data for the Semester 2 (2020) Statistical Report will be based on full logbook returns.

The annual retained catch data for Seychelles-flagged large-scale fishing vessels showed the following:

- Purse seinerfishery: The published retained catch data is <u>disaggregated</u> by a number of attributes, fulfilling the requirements of the FiTI Standard. Disaggregation includes:
 - by month, quarter, semester,
 - target species (i.e. Yellowfin, Skipjack, Bigeye, Albacore, others),
 - geographical area (Seychelles EEZ, foreign EEZ (not further defined) or the High Seas),
 - whether the catch has been made in a free swimming school, is FAD-associated or unidentified.
- Industrial longline fishery: The published retained catch data is also <u>disaggregated</u> by a number of attributes, albeit fewer than the purse seiner fishery, but still fulfilling the requirements of the FiTI Standard. Disaggregation includes:
 - by month,
 - by target species or species groups (i.e. Yellowfin, Bigeye, Swordfish, Marlin, Sharks, others),
 - by geographical areas (Seychelles EEZ, foreign EEZ (not further defined) or the High Seas).
- Catches of foreign-flagged vessels: Data on retained catches from active foreign-flagged large-scale fishing vessels for 2020 is available online, published in the Semester 1 Fisheries Statistical Report (2020).
 - **Purse seiner fishery:** The published catch information from all foreign-flagged purse seiner vessels *is perceived as nearly complete*. Catches made in 2020 are

summarised below (in Mt), disaggregated by species, flag State and geographical area⁴².

- whether the catch has been made in free swimming school, is FAD associated or unidentified, and
- the agreement under which the access regime is defined (EU, others).
- Industrial longline fishery: The published retained catch data for the foreignflagged longline fishery is again *incomplete*, as it
 - covers only Semester 1 (January-June 2020) data from Seychelles- and Taiwan (POC)-flagged vessels and only Quarter 1 (January-March 2020) data from all other flagged-vessels, and
 - the catches made in Semester 1 (January-June 2020) are based on only 91%
 logbook returns (98% for Taiwan POC, 86% China, 10% Spain, 0% Portugal and 0% France).

Reported catches by foreign-flagged longliners made in the first semester of 2020 are summarised below (in Mt)⁴⁵, disaggregated by species and geographical area:

In addition to the above shown disaggregation, the published retained catch data is further <u>disaggregated</u> by a number of attributes, fulfilling the requirements of the FiTI Standard:

- by month,
- by target species or species groups (i.e. Yellowfin, Bigeye, Swordfish, Marlin, Sharks, others),
- by the agreement under which the access regime is defined.

The issue of vessels not returning their logbooks and the fact there are no penalties in place for non-return impacts the credibility of the compiled volume of catches made.

- Landings and transshipments in Seychelles' ports: Data on landings and transshipments in national ports from large-scale fisheries for 2020 was available online, published in the Semester 1 Fisheries Statistical Report (2020).
 - Purse seine fishery: Total landing and transshipment in Port Victoria by purse seine vessels licenced to fish in Seychelles' waters for 2020 is summarised below (in Mt), disaggregated by Flag State.

The published landing data for 2020 is *perceived as complete*. As previously noted in the 2019 FiTI Report and reiterated here once again, the published landing and transshipment data cannot be not considered to be in full accordance with the FiTI Standard, as the data was not disaggregated in a manner that allowed catches made in Seychelles' waters to be separated from those made in other national

jurisdictions or on the High Seas. The National MSG was informed that this transparency requirement poses a practical challenge, as catches made in different locations are stored in the same wells and can therefore not be physically separated.

Despite the practical challenges posed to data disaggregation, it is notable that the data set is further <u>disaggregated</u> by several other attributes, including:

- month,
- flag State (data is provided separately for the three main flag States (i.e. Seychelles, France and Spain), and grouped for the other three countries with smaller numbers of vessels (i.e. Italy, Mauritius, Korea)),
- fish species (i.e. Yellowfin, Skipjack, Bigeye, Albacore, Mix species),
- fish size categories (< 10kg and > 10kg for Yellowfin and Bigeye; < 1.8kg, 1.8-
 3.4 kg, > 3.4kg for Skipjack),
- whether the landing is to reefer vessels, IOT or reefer containers,
- the agreement under which the access regime is defined (national, European Union, Others, and discards).
- Industrial longline fishery: Data on landings and transshipments made in Seychelles' ports for 2020 have not been published at all, due to technical software issues. The FINNS statistical system that is currently being used by SFA cannot be used to capture landing and transhipment data. SFA intends to include landing and transhipment data in the new 'ObserveLL' system which has been developed for all industrial and semi industrial data.

However, landing and transshipment data for all industrial longliners licenced to fish in Seychelles' waters is recorded on landing and transhipment forms, which are submitted to the MCS Division of SFA for verification prior to onward submission to the IOTC.

Landings and transshipments in foreign ports: Data on landings and transshipments in foreign ports by the large-scale sector for 2020 is partially available online, as published in the Semester 1 Fisheries Statistical Report (2020).

Similar to landings and transshipments in national ports, the data for foreign ports cannot be disaggregated in a manner that allows catches made in Seychelles' waters to be separated from those made in other national jurisdictions or on the High Seas.

Purse seine fishery: Published 2020 data indicates that a total of 18,107 Mt of fish caught by purse seiners licenced to fish in Seychelles' waters were landed or transshipped in foreign ports in 2020. This equates to 5% of the catch that is made by purse seine vessels licenced to fish in Seychelles' waters.

Four foreign ports, were used in 2020 for landings and transshipments. These were Diego Suarez (Madagascar), Port Louis (Mauritius), Mombasa (Kenya) and Busan (Korea)⁴⁸ in order of volume landed. In addition to the port, the data set is further <u>disaggregated</u> by several other attributes, including:

- month, quarter, semester,
- fish species (i.e. Yellowfin, Skipjack, Bigeye, Albacore, Mix species), and
- discards.

Published data on landings and transshipments in foreign ports is not disaggregated by flag State, despite the fact that this information is collated by SFA, as landings and transshipments in foreign ports are minimal compared to national ports.

- Industrial longline fishery: Such data for 2020 has not been published by Seychelles' authorities, despite the fact that the majority of data is being collated by SFA. SFA claims that their level of confidence in the data is low as they do not have a system in place to assess the accuracy of the data.
- Discards: Data on fish discards has been published in the Semester 1 Fisheries Statistical Report (2020). However, this relates only to information from the purse seine fishery; no information from the industrial longline fishery has been published. Discards data from the industrial longline fishery is expected to be published for the first time in the Semester 2 (2020) Fisheries Statistical Report.
 - Purse seine fishery: Published discard data shows that, in 2020, a total of 4 Mt of discards were unloaded in Port Victoria, whereas no discards were unloaded in foreign ports.

In addition to port information, this data set is further <u>disaggregated</u> by month, quarter, semester and year, but not by species or species groups (as required by the FiTI Standard). SFA informed the National MSG that at present it is not possible to publish discard data from the purse seine fishery disaggregated by species as this information is received by SFA in a non-disaggregated format.

The National MSG also took note that by the end of 2020, the Seychelles' authorities had undertaken no work to verify the accuracy of discard information. In 2019, SFA piloted an Electronic Monitoring project on industrial longliners to address the lack of observations at sea for this component of the Seychelles' fishery. Three vessels were equipped with sensors and cameras to record setting and hauling activities, estimate the size and species composition of the catch retained and discarded, and monitor transshipments at sea. The analysis from the on-board observations was made by The Nature Conservancy (TNC) and

had not been published by the end of 2020. SFA is unsure whether the report will be disseminated publicly once completed.

Finally, discards of non-fish species are recorded by both the purse seine and industrial longline fishery and reported to the IOTC through the annual National Reports to the Commission's Scientific Committee. For sharks, marine turtles, sea birds, and marine mammals, reports also include information on whether the animal is discarded alive or dead. The Seychelles National Report to the IOTC for the calendar year 2019 was submitted in June 2020, while the one for the calendar year 2020 was submitted in November 2021. As part of this FiTI reporting process links to the two reports was published on the SFA website.⁴⁹

- Fishing effort: Data on fishing effort of Seychelles-flagged and foreign-flagged largescale vessels for 2020 was published online, through the Semester 1 Fisheries Statistical Report (2020). *However, this data is incomplete* for the following reasons:
 - Data is only available for Semester 1 (January June 2020) for Seychelles-flagged and Taiwan (POC)-flagged industrial longline vessels;
 - Data is only available for Quarter 1 for industrial longline vessels of other flags.

Furthermore, as already stated above, the published Semester 1 effort data for the industrial longline fishery is based on 82% of logbook return for Seychelles-flagged vessels, and 91% for other fleets.

For both, the purse seine and industrial longline fishery, SFA collects and archives data on fishing effort by individual vessel. However, the authorities have never published such data.

Purse seine fishery: Data on fishing effort is published as *days fished*. Published data for 2020 indicates that purse seine vessels licenced to fish in Seychelles' waters spent a total of 10,548 days fishing in the Western Indian Ocean, of which 3,127 days were spent fishing within Seychelles' EEZ.

The following table summarises fishing effort of purse seiners licenced to fish in Seychelles' waters for the year 2020, disaggregated by flag State and geographical area where fishing took place.

In addition to the above shown <u>disaggregation</u>, fishing effort can also be disaggregated by other attributes, including:

- month, quarter, semester, year,
- the agreement under which the access regime is defined (European Community, others).
- Industrial longline fishery: Fishing effort data is published as the number of *hooks* set. Published data indicates that the industrial longline vessels licenced to fish in Seychelles' waters deployed over 18.4 million hooks in the Western Indian Ocean during the first semester of 2020, of which over 7.5 million were within Seychelles' EEZ.

Evaluation or audits of the economic, social and food security contribution of the large-scale fishing sector: No evaluations of the *economic contribution* of the Seychelles' large-scale fishing sector have been undertaken for 2020⁵².

[Best available information] The National MSG found no instances relating to the assessments of catches and information on by-catch/discards, as well as evaluations of social and economic impacts of Seychelles' large-scale fisheries, where information used by national authorities is clearly misleading, or could be improved by considering alternative sources of information, such as studies by non-governmental organisations, the private sector or academic institutions.

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding catches made by large-scale fisheries:

Small-scale fishing vessels and fishing vessels licences: SFA has published a downloadable Excel document on its website displaying lists of all small-scale fishing

vessels licences and fishing activity licences issued in in 2020⁵³. This information is summarised in the table below.

The published licences are disaggregated according to fishery or fishing activity and include five lists as follows:

- Artisanal fishery, with 466 vessels listed. Parameters provided include: the vessel SFA number (435)⁵⁴, vessel class (464), vessel length (464), vessel name (315), vessel type (465), start date of licence (466), end date of licence (466).
- Net fishing activity licences, indicating that 40 net fishing activity licences were issued in 2020. Parameters provided include: name and surname of the licensee (40), licensee address (40), net tag number (36), type of material used for making the net (36), type of species being targeted and the start (40) and end date (40) of the licence.
- Lobster fishery, indicating the 16 lobster fishery licensee for 2020-2021 fishing season. Parameters provided include: the SFA vessel number (15), vessel name (7), name of crew for each licenced vessel, vessel landing site (16). All but one applicant were commercial fishermen that already had licenced fishing vessels.
- Semi-industrial longline fishery, with 30 vessels listed. Parameters provided include: vessel name (30), SZ number (30), SFA number (28), vessel length (30), vessel width (30), engine type (30), engine horsepower (30), start date of licence (30), end date of licence (30). It is noteworthy to highlight that the Semester 1 Fisheries Statistical Report (2020) states 35 semi-industrial vessels licensed for 2020. This does not correspond to the number of licenced vessels as per the list published on the SFA website. Discrepancies may derive from the fact that certain vessels licenced in 2019 were still active in 2020 and did not seek a new licence in 2020.
- Semi-industrial sea cucumber fishery, indicating the 25 licenced sea cucumber vessels for the 2020-2021 fishing season. Parameters provided include: vessel name

(25), SZ number (25), licence validity (25). Licence details in the published list appear to cover the 2020/2021 seasons while for others it is the 2021/2022 season.

A breakdown according to gear type is not provided, as many boats in the small-scale fisheries are multi-geared.

The published lists of vessels do not include hire craft vessels organising fishing trips for paying visitors (which need to be registered with and licenced by the Seychelles Maritime Safety Authority (SMSA)) and non-commercial vessels used for recreational fishing (which have no legal obligations to be registered).

Fishers engaged in the small-scale fishing sector: Such information for 2020 has been collated by SFA and a summary is published online⁵⁵ and is reproduced in the table below for the year 2019 and 2020. SFA keeps track of the number of registered commercial fishers through its fishermen registration card programme. However, no details are provided on whether the registered fishermen are full-time, part-time or occasional fishers

The summary data shows that the number of registered fishers increased dramatically in 2020, possibly in response to the COVID-19 relief employment benefits that were being made available to fishers.

Payments made from the small-scale fishing sector: Payment information from the small-scale fisheries sector is collated by SFA and was made available to the National MSG on a per licence per vessel basis. The total licence payment made for small-scale fishing fisheries licences in 2020 amounted to SCR 524,450. As the details of payments are not included with information on small-scale fishing vessels licences and fishing activity licences published on the SFA website⁵⁶, the National MSG cross-checked payments information with the published lists of licences issued and provide the results

in Annex C as an interim measure until SFA is able to publish the details on its website. The National MSG made the following observations:

- Out of the SCR 524,450 collected by SFA, SCR 479,300 could be linked to a specific fishing vessel licence or fishing activity licence.
- There were 22 artisanal fisheries licences and 4 semi-industrial fisheries licences for which the National MSG was *not able to link to a payment.*
- SCR 45,150 paid to SFA as fishing vessel licence or fishing activity licence could not be linked to a vessel on the lists of fishing vessel licences published by SFA. This suggest that there could be errors in details of payments and/or that there are vessels for which fishing licences were paid in 2020 which does not feature on the list of licences published by SFA.
- Licence payment for the *lobster fishery* was not included in the payment information that was made available by SFA.
- Catches by the small-scale fishing sector: Such information is published in the Semester 1 Fisheries Statistical Report 2020.
 - For the *artisanal fishery*, the published catch data is incomplete as it only accounts for Semester 1 (January – June 2020). Furthermore, no catches from the sea cucumber and lobster fisheries are included⁵⁷. Catch data is disaggregated by vessel type, month, gear type and species groups, but not by individual species.

• For the *semi-industrial longline fishery* the data is based on 100% logbook return and is seen as complete. Catch data is disaggregated by month, species (Yellowfin, Bigeye, Swordfish and sail fish) and species group (Marlins, Sharks, others).

- Discards by the small-scale fishing sector: The government of Seychelles does not collect any statistics or publish studies on the species and volumes of fish discarded in the small-scale sector. The volume of discards in these fisheries is generally seen as being insignificantly small. The vast majority of fish caught in the small-scale fisheries are sold for human consumption. Fish not used for human consumption are usually used as bait or as food for domestic animals.⁵⁸
- Economic, social and food security contribution: No such evaluation or audit was undertaken by Seychelles' authorities in 2020. As previously noted, the GDP contributions of the fisheries sector for the year 2020 (though not disaggregated by sub-sector) is published by the government of Seychelles through the Q4 2020 Quarterly National Accounts Statistics produced by the National Bureau of Statistics (NBS).

- Total quantity of fish and fish products produced: The total quantity of fish and fish products produced for the year 2020 is published as part of the Production Indicator Q4 2020 Statistical Bulletin⁵⁹. The information provided (60,849 Mt) only accounts for fish catch, production of canned tuna and smoked fish. The SFA Annual Reports typically delve into greater detail on fish and fish products produced. However, the last annual report produced dates back to 2018⁶⁰. It is further noted that the information on the total quantity of fish and fish products produced in 2020 published in the Production Indicator Q4 2020 Statistical Bulletin is not disaggregated by individual species as multiple species can be used to make the same product.
- Imports of fish and fish products: The total amount of imports of fish and fish products for 2020 is published as part of the Merchandise Trade 2020 Q4 Statistical

Bulletin of the NBS.⁶¹ This bulletin only refers to the total monetary value of imports, using the Harmonized System Codes, and does not cover the weight, species or country of origin of the import. However, these aspects are documented by the NBS, and passed on to SFA, which incorporates them into its annual report. As stated already, the publication of the 2020 annual report is delayed. The import value for 2020 stood at SCR 2,408,847,000. No information on the total imported weight is published for 2020. In 2020, a total of 38,705 Mt. of frozen fish was landed in Port Victoria by foreign-flagged purse seiners, mostly destined for the tuna canning factory.

Exports of fish and fish products: The total quantity of exports of fish and fish products for 2020 is also published as part of the NBS' Merchandise Trade 2020 Q4 Statistical Bulletin. Published export data is disaggregated according to the Harmonized System Codes and falls into five categories, as shown below.⁶² The NBS' published export data is not disaggregated to species level.⁶³

- Employment in commercial fisheries sector: No accurate estimate of the number of people employed in Seychelles' commercial fisheries sectors, including the number of men and women working in specific sub-sectors, was published for the year 2020. The National MSG was unable to determine whether such a total number is available in the government's systems at all. A study was initiated in 2020 to undertake an employment and capacity needs assessment study for the fisheries sector in Seychelles⁶⁴. Results are yet to be published.
- Employment in *informal* fisheries sectors: No employment information for the informal fisheries sector is collated by the Seychelles' government. In the country's 2019 FiTI report, the National MSG stated its belief that Seychelles does not possess a substantial informal fisheries sector. However, for the year 2020, MOFBE was of the opinion that though small, an informal sector does exist in Seychelles, particularly where it concerns fish mongers⁶⁵ and the still unlicensed octopus' fishery. Recommendation 2019-7_3 of the 2019 FiTI report encouraged MOFBE to clearly state whether an informal fisheries sector exists in Seychelles. This responsibility has since been transferred to SFA. However, SFA had issued no official statement on the existence of an informal fishing sector before the publication of this FiTI Report.

[Best available information] The National MSG found no instances relating to employment statistics in Seychelles' informal sector, where information used by national authorities is clearly misleading, or could be improved by considering alternative sources of information, such as studies by non-governmental organisations, the private sector or academic institutions.

Wages in the post-harvest sector: Information on wages in the post-harvest sector is not collated and there are no reports or studies which have been published to date on this topic. The NBS publishes total wages in the fisheries, agriculture and forestry sector combined, but it is not clear which components of the fisheries sector this involves. Also, the annual average employment (585 people) in the sector for 2020 appears to be underestimated.

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding the post-harvest sector and fish trade in Seychelles:

Activities and strategies for ensuring compliance: In 2020, no comprehensive report was produced on the national activities and strategies used to ensure compliance of fishing vessels and the post-harvest sector with Seychelles' legislation.

SFA is responsible for Monitoring, Control & Surveillance (MCS), as per its legal mandate under the SFA Establishment Act (1984) and the Seychelles Fisheries Act (2014). However, as of the end of December 2020, SFA had not published an overall MCS strategy.

Several compliance and policy instruments do exist, providing strategic direction regarding fisheries compliance. *These are detailed in the 2019 FiTI report. No new compliance-related strategy documents were produced in 2020.*

The National MSG notes that while there were activities being undertaken to monitor certain aspects of the post-harvest sector such as inspections and verifications, there was no overall strategy in place to guide these activities.

The 2019 FiTI Report acknowledged that work was underway within the Trade Division of the Ministry of Finance, Trade, Investment and Economic Planning⁶⁶ towards improving fisheries catch certification before export, but no further information could be obtained on how the work had evolved in 2020.

A recommendation was made by the National MSG for SFA to provide MOFBE with regular information regarding the national strategies and activities applied to ensure compliance

of fishing vessels and the post-harvest sector was made in the 2019 FiTI Report (2019- 8_1). Addressing this recommendation is due by December 2022.

Financial and human resources deployed to ensure compliance: The National MSG found that no consolidated information on the financial and human resources deployed by all relevant national authorities⁶⁷ to ensure compliance with national fisheries legislation was available for the year 2020.

Information provided by SFA as part of this FiTI Report shows that the MCS Division had *a* total expenditure of SCR 21,397,937⁶⁸ for 2020, of which

- 50% was derived from SFA's recurrent budget , and the other
- 50% from the sectoral support under the protocol of the EU/Seychelles Sustainable Fisheries Partnership Agreement.

A recommendation was made by the National MSG for SFA to prepare and make available to MOFBE the financial and human resources deployed by the government (including other agencies apart from SFA) to ensure compliance with national and international legislation in the fisheries sector (at least on an annual basis) by December 2023 (2019-8_2). As part of this reporting process, SFA informed the National MSG that it has already initiated discussions with the National Information Sharing and Coordination Centre (NISCC) and the Seychelles Coast Guard (SCG) to gather this information and better coordinate their enforcement activities, including through training activities. SFA has pledged to publish this information for the year 2022 by early 2023.

Inspections at sea and in ports: Inspections data has not yet been published for 2020. This information is typically compiled quarterly by SFA, with annual totals published as part of the SFA Annual Report, though the 2020 edition of this report remains unpublished. However, as part of this FiTI reporting process, SFA made information on the quantity and types of inspections and patrols accessible, which is summarised in the table below. The 8 air patrols were conducted in conjunction with the Seychelles Air Force. Financial information also made available by SFA as part of this FiTI reporting process indicates it paid a total of SCR 2,023,996 for the air patrols.

Record of convictions and major offences⁷⁰: A record of convictions of major offences in the fishing sector during 2020 is collated by SFA, but not published online. A list of offences was made available during this FiTI reporting process and is provided in Annex C. The list provides some details on the type of offences recorded and actions taken by SFA and, in a limited number of cases, the name of the vessel involved. No details are provided on the owner of the vessel involved in the incident or the date it occurred. A list of foreign-flagged vessels which have been apprehended for IUU fishing is maintained by the MCS Division of SFA. The list of foreign vessels apprehended in 2020 as a result of IUU fishing in Seychelles' waters, as well as the outcome of the subsequent court cases, is provided in Annex C.

Recommendations

Summary description of national laws on labour standards: A summary description of Seychelles' labour standard laws applicable to national and foreign workers employed in the fishing sector (either at sea or for those in the post-harvest sector) did not exist in 2020.

The National MSG recommended in its 2019 FiTI Report that MOFBE publishes such a summary description by December 2021 (*2019-9_1*). *This recommendation has not been fulfilled yet.*

Enforcement of labour standards: The Ministry of Employment and Social Affairs (MESA) is responsible for monitoring and enforcing laws on labour standards in the fisheries sector in Seychelles (as well as in other sectors). A statement to that effect is clearly published on the information page related to the Labour Relation Division of the MESA⁷¹, but not yet on the website of MOFBE or SFA.

Documents, including policy statements and evaluations, regarding a national strategy, if applicable, or related activities for enforcing the laws on labour standards in the fisheries sector: The Fisheries Comprehensive Plan addresses adherence to labour standards only onboard Seychelles-flagged large-scale fishing vessels⁷², but not in the artisanal or semi-industrial longline fisheries. The Plan also acknowledges operational challenges by stating that 'The Seychelles-flagged longline fishing vessels employ crew of different nationalities coming from different parts of the world, such as Philippines, Indonesia, China etc. As these vessels do not frequent Port Victoria, the respective authorities are unable to ensure that the working conditions of the crew on board these vessels or their contract of employment are in order.'

Furthermore, under policy 7 of the Seychelles Fisheries Policy and Strategy, which addresses *Employment, training, resourcing and human resource development,* a statement regarding labour issues is given⁷³.

For 2020, MESA reported that it has 15 inspectors enforcing labour standards across all sectors of the economy, including fisheries. The budget⁷⁴ of the Labour Protection Programme⁷⁵ for 2020 was SCR 6,487,000, of which over 93% went towards wages and salaries of staff.

- Mandate to receive labour complaints: Complaints related to workers' grievances are usually channelled through the Labour Relation Division of the MESA. No explicit reference is made to receive labour-related complaints from workers in the fishing and post-harvest sector.
- Number of offences committed by employers in the fisheries sector that have been resolved by the authorities: No such information is published, neither by MESA, MOFBE or SFA. Through this FiTI reporting process, MESA reported that in 2020 there were no labour offences recorded for the fisheries sector. MESA also took the opportunity to clarify the distinction between 'offences' and 'grievances.' It was noted that 'offences' are detected/established by the labour inspectors and enforced, whereas 'grievances', are complaints brought forth by employees, which may constitute offences not sufficiently proved to be addressed by enforcement and which are consequently 'resolved' (if possible) by way of mediation.

As a general remark, the National MSG determined there is still very little (if any) information provided by the government of Seychelles regarding fisheries subsidies. A comprehensive report on the value of government subsidies and financial transfers made to Seychelles' entire fisheries sector was neither existent for 2020, nor any previous years.

This is in particular noteworthy as subsidies have become one of the *most controversial subjects in debates on fisheries reforms*. Policy 4 of the Seychelles Fisheries Policy and Strategy focuses on *'Building efficiency in the industry'*, listing a number of strategies aimed at addressing overcapacity and subsidy dependency in the small-scale fisheries sector.

As already stated in more detail in the 2019 FiTI Report, this lack of information also challenges national legal obligations, for example, Seychelles' Access to Information Act. This Act legally mandates government organisations to publish detailed information on the design and execution of any subsidy programmes implemented with public funds.

Both MOFBE and SFA have published the names of their respective Information Officers in the Official Gazette, whose duties include (amongst others) ensuring that such information related to fisheries is published.

This lack of information *triggers also uncertainty* about what constitutes a financial transfer or subsidy to the fisheries sector. No definition or explanation is published on the websites of MOFBE or SFA. The parameters for defining what is and is not a subsidy is not just a technical matter: it determines what government information is subject to disclosure.⁷⁶

- Subsidies given to large-scale fisheries in Seychelles: No information of government financial transfers or subsidies provided to large-scale fisheries is published and the National MSG was unable to determine whether such subsidies are given at all and under what conditions. The National MSG was however able to determine that large-scale fishing vessels are able to buy fuel duty free in Port Victoria. This is not a privilege specific to the fisheries sector as all international vessels buy fuel duty free.
- Subsidies given to small-scale fisheries in Seychelles: The 2019 FiTI Report provides a summary of the subsidies that are available to the small-scale fisheries. These remain unchanged for the year 2020. Recommendation 2019-10_1 of the 2019 FiTI Report urged SFA to publish on its website the 2017 report that reviewed subsidies provided to the artisanal fisheries sector' which they had commissioned. This report was published on the SFA website as part of this FiTI reporting process⁷⁷.
- Fuel subsidies: Information about the fuel incentive scheme (FIS) for the small-scale fishing industry is available online from the SFA website⁷⁸. Under this scheme eligible benefactors benefit from a reduction in fuel at the concession rate of SCR8.50 per litre. Based on information obtained from SFA as part of this FiTI reporting process, the total value of fuel subsidies given to the small-scale fishing sector in 2020 amounted to SCR 59,739,194 for a total of 7,041,797 litres of fuel. This information is available on a per vessel basis, but not yet published on a government website. According to recommendation 2019-10_2, this information should be published by December 2022.
- Ice subsidies: Information made available by SFA as part of this FiTI reporting process on the price of ice sold to fishermen compared to the general public is provided in the table below. The normal price of ice sold to fishermen is already subsidised by the government, and from April 2020 up to March 2021 this price was further reduced in the scope of COVID-19 support extended to the fishing sector.

Information provided by SFA as part of this FiTI reporting process (in the table below) shows the cost of operating ice plants in Seychelles (excluding labour) during 2020 was SCR 8,001,079.24, while the earnings from the total sale of ice amounted to SCR 2,721,156.12. This equates to a total subsidy of *SCR 5,279,923.12*.

The National MSG found that there are only a limited number of fisheries public sector projects which were funded through ODA in 2020, compared to a wider variety of marine conservationrelated projects. These projects are funded through a mixture of bilateral, multilateral and private donors. Summaries of these projects were compiled by the National MSG and are made available in the tables below.

Fisheries-related public sector development projects: There were only two ODA-funded national fisheries public sector projects under implementation in 2020. No information is published online by Seychelles' national authorities and has therefore been compiled in Annex C of this FiTI Report.⁸⁰

The SFA webpage dedicated to fisheries infrastructure projects⁸¹ makes no reference to the JICA-funded project and no references exist to the website of JICA, nor any of the development partners. There is also no mention of the SWIOFish3 Project on the websites of the MOFBE nor that of SFA. The SWIOFish3 project has its own website⁸², which provides details of the project objectives, components, funding sources, results and quarterly reports. However, the website only identifies the government of Seychelles as a partner and not as the executing entity.

Regional fisheries projects: The only known regional fisheries project from which Seychelles benefits is the Ecofish Programme⁸³ (2018 – 2024) funded by the European Union at a cost of EUR 28 million. The total direct benefit for Seychelles for the year 2020 is not known. There is no mention of this project on the websites of the MOFBE or SFA. However, some of the project meetings held in Seychelles are covered as news items on both websites.

EU Economic Partnership Agreement: Seychelles is benefitting from a long-term technical assistance programme to support the implementation of the European Union and Eastem and Southern Africa (EU-ESA) interim Economic Partnership Agreement (EPA). This is funded through a grant of EUR 10 million from the 11th European Development Fund. The objective is described as aiming 'to reinforce the capacity of key partners to better implement trade and regional integration agreements and support private enterprises in the manufacturing, agriculture and <u>fisheries sectors</u> to boost their production and produce higher value products with high export potential – through diversification and through innovation.' However, there is no mention of this agreement on the website of the Ministry of Foreign Affairs and Tourism nor on any other government of Seychelles' websites.

Conservation-related public sector development projects: There are several marine conservation-related projects implemented in Seychelles, but there is no comprehensive overview of them provided by the government of Seychelles. Information obtained from the Public Budget Management Section of the Ministry of Finance, Economic Planning and Trade during this FiTI reporting process indicates there were five nationally-implemented marine conservation-related public sector projects that were under implementation in 2020. A summary of these projects and related evaluations is provided in Annex C.

It is known that there are other ODA-financed marine conservation projects under implementation in 2020 such as those related to the Seychelles Marine Spatial Planning Process⁸⁴ and the Seychelles Climate Change Adaptation Trust (SeyCCAT)⁸⁵. These initiatives have their own websites but information about project value and whether any evaluations have been undertaken is not readily available.

The National MSG determined that it goes beyond the scope of this report to compile a comprehensive list of ODA projects related to fisheries and marine conservation that were under implementation in 2020. Instead, several agencies that fund and/or implement conservation-related public sector projects are listed. It is uncertain whether other projects exist, what their values are, how their implementation and impact is evaluated etc.

• The website of the Project Coordination Unit⁸⁶ within the Ministry of Agriculture, Climate Change and Environment provides a comprehensive list of conservation and other environment-related projects, dating from 2007. Most of these projects have been funded by the *Global Environment Facility (GEF)* and implemented by the *United Nations Development Programme (UNDP)*. Project objectives, start and end date, funding agency, grant amount, project manager and current status are

displayed. Hyperlinks for technical reports, project evaluation reports and other documents produced as part of the implementation of these projects are provided, but for a number of projects, no such documents are published online. The GEF website⁸⁷ also provides a list of all national, regional and global projects through which Seychelles has benefited. While not all the projects are marine-based, most of them have implications for the management of Seychelles' marine environment. The projects which have so far been funded by GEF amount to USD 34,950,400. No new national GEF-funded projects were approved in 2020.

- A list of projects funded by the *World Bank* for Seychelles is also accessible online through the Bank's website⁸⁸ that provides details of project titles, committed amount, approval date, status and the date the information was last updated. Projects can be filtered according to a number of attributes, including sector, which allows for the selection of 'Fisheries' projects. No new national World Bank-funded projects were approved in 2020.
- Information regarding total ODA provided to Seychelles since 2010 can also be obtained through the website of the Organisation for Economic Co-operation and Development (OECD)⁸⁹. However, data is only available for the period 2010 to 2017. Information on bilateral aid and that provided by major foundations can also be obtained online through the OECD's Development Co-operation Profiles Report⁹⁰, but the data is not specific to fisheries or marine conservation.

Legal basis for and definition of beneficial ownership: Prior to 2020, the Fisheries Act (2014) was one of the rare legal instruments that defined beneficial ownership, albeit specifically relating to the fisheries sector. Section 8(2)(r) of the Act required SFA, as part of its record of fishing vessels, to register the name, address and nationality of any person with beneficial ownership of a fishing vessel. It also makes provision for SFA to refuse the granting of fishing licences to foreign fishing vessels (Section 11(6)(b)) and sport fishing vessels (Section 18(5)(c)) with a record of non-compliance with international fisheries conservation and management measures. The exception is where ownership of the vessel has changed and the new owner provides sufficient evidence to satisfy the Authority that the previous owner or master has no legal, beneficial or financial interest in, or control of, that vessel.

The promulgation of the Beneficial Ownership Act (2020) and Beneficial Ownership Regulations (2020)⁹² established the legal basis for beneficial ownership registration beyond the requirements for licensing vessels and fishing activity permits provided for in the Fisheries Act. A legal opinion obtained for this reporting process stated no inconsistencies between the definition of a beneficial owner in the Fisheries Act and the Beneficial Ownership Act.

- Public register of beneficial owners: By the end of 2020, Seychelles did not have a 0 central register of beneficial owners. The Beneficial Ownership (BO) Act makes it a requirement for every legal person or legal arrangement to maintain an up-to-date register of beneficial owners at the principal place of business of its resident agent. Such information must be reported to the Financial Intelligence Unit (FIU), which is responsible for populating the information in a central beneficial ownership database. This database became active on 5th July 2021 for the registration of the resident agents that will be populating the database⁹³. However, the register and the database is not publicly available; instead, the BO Act makes provision for institutions specified under the Act to access information (Section 13(4) and Section 14). The list of Competent Authorities does not include SFA.
- 0 Incorporating beneficial ownership in filings by companies: The National MSG determined that beneficial ownership transparency in fisheries has been neglected in Seychelles, despite international policy debates and national obligations. For example, paragraph 8(2)(r) of the Fisheries Act (2014) states clearly that 'the record of fishing vessels shall contain the name, address and nationality of any person with beneficial ownership of the fishing vessel.' Yet such information is rarely compiled, if at all. Very few of the Seychelles-flagged vessels in the IOTC Record of Currently Authorised Vessels had actual beneficial owner information listed.

Current status and discussions around beneficial ownership transparency 0

in fisheries: Although the BO Act is not industry-specific, it captures all legal persons or arrangements registered in Seychelles, both by the Financial Services Authority and the Registrar. As such, if a fishing vessel is owned by a legal person or arrangement registered in Seychelles, that legal person/arrangement is subjected to the BO Act and must maintain, through their resident agents, a Register of Beneficial Owners, and populate their beneficial ownership information in the central database. The Fisheries Act also requires SFA to collect beneficial owner information upon the registering of fishing vessels. However, this is rarely done. SFA states that even though the Fisheries Act compels them to record beneficial ownership information upon the registry of fishing vessels, the Act does not make it an offence for vessel operators not to divulge the name of beneficial owners and does not impose any penalties for not reporting such information.

As per the requirement of the Beneficial Ownership Act, efforts are underway on policy/implementation procedures for addressing beneficial ownership transparency in

fisheries. Information from the FIU indicates that agents had until the 31st October 2021 to register the details of beneficial owners of offshore companies (the majority of Seychelles-flagged industrial fishing vessels are owned by such companies). After this date, the Beneficial Ownership database was opened for the registration of domestic companies, which will have up to 31st January 2022 to register themselves. An awareness campaign is expected to be launched to educate businesses about this legal requirement before domestic registration starts. There is, as of yet, no clear timeline from SFA on when they expect to compel vessel owners to provide beneficial ownership information.

Recommendations

We, the National MSG, make the following recommendations to improve transparency regarding beneficial ownership in Seychelles' fisheries sector:

Annex A. Statement of the Report Compiler

I was appointed on the 3rd August 2021 by the Seychelles' Department of Blue Economy to prepare Seychelles second report to the Fisheries Transparency Initiative (FiTI). Funding for this assignment came from the Third South West Indian Ocean Fisheries Governance and Shared Growth Project (SWIOFish3). This report was compiled based on the guidelines provided by two important reports published by the FiTI secretariat, namely: (i) The FiTI Standard and (ii) Guidance Note #2 Compiling FiTI Reports. The Seychelles First FiTI Report, which I had prepared on behalf of the National MSG eight months earlier provided baseline information on which the current report is built.

Extensive consultations were undertaken with the Seychelles Fishing Authority and other stakeholders working in the specific area for which information was required. It was encouraging to find, that during this FiTI reporting process the majority of recommendations which had been made in the first FiTI report and which was due at the end of 2021 had already been implemented. A few recommendations are still being worked on and some have been differed to next year due to time and staff constraints. I am encouraged that none of the recommendations made in the first FiTI report was rejected by the Government.

The major challenge that I encountered in compiling this report was a lack of validated information. For example, information on the total amount of fuel subsidies provided to the small-scale fishing sector had not been compiled by the authorities by mid-2021. Likewise, payments for fishing licences for both the large-scale and small-scale fishing sector had not been checked for completeness. These are just two issues that I identified. As a result, I had to spend a considerable amount of time compiling and cross-checking data so that such information could be provided as part of this report. Another challenge that I encountered was with changes to information on the SFA website. There were much needed information required by the FiTI standard on the SFA website that were removed during this FiTI Report preparation process. I was however able to work with SFA to ensure that the required information are published and updated as required.

One thing that I am especially proud of, that was undertaken as part of this FiTI report preparation process, is the compilation and publication of the large-scale vessel registry. The registry has fields for all 14 vessel attributes required by the FiTI standard as well as licence payment information. The fact that such a registry is now in the public domain is a major step in promoting fisheries transparency in the Seychelles. The next major task to be implemented with respect to the vessel registry is for SFA to ensure that the required information is available and verified for all of the required vessel attributes. It would make an important contribution to fisheries transparency in the Seychelles if SFA could restructure their website to improve the ease of navigation and to make documents easier to locate. I must take this opportunity to thank the National MSG for their guidance with the preparation of this report. The staff of the Seychelles Fishing Authority were all extremely helpful and were eager to work with me to ensure that the FiTI transparency requirements were being met. The website of the Ministry of Fisheries and the Blue Economy also provided a wealth of information, especially where fisheries related legislations, policies and plans are concerned.

Overall, I found that the Government authorities were very much interested in the Fisheries Transparency Initiative as a whole and found value in having the information related to fisheries in the public domain.

Participation of members in National MSG meetings organised as part of this FiTI Report preparation process was low for a number of reasons. I hope that the National MSG could be revitalise and I look forward to more debate at the National MSG level and nationally based on the findings of this second FiTI Report.

I would like to take this opportunity to thank all of the stakeholders who have taken time to provide requested information and discuss various components of the report with me either in person, through emails, or virtual meetings. I would also like to thank the National MSG for their guidance and also the FiTI International Secretariat for supporting this reporting process.


