

English River Project looking promising




With work on the English River Project progressing steadily, the fishermen are looking forward to the development of the proposed facilities that will improve their infrastructure for selling fish and storing gears.

Within one month, the dredging work to improve the channel and expand the basin for mooring purposes has been completed, and the reclamation work has started to prepare the terrain for the fishing facilities. This project, funded by the European Union, is being led by the SFA's project team.

The overall scope of work includes reclamation, dredging works, as well as construction of a fish market, gear stores, and installation of pontoons. The goal of the project is to provide a more suitable facility for the English River fishing community.

Budget management course for managers

In an era where financial acumen is vital for effective leadership, a group of managers recently participated in an enriching two-day budget management course held at Unisey. This program aimed to equip leaders with the necessary tools and strategies to navigate the complexities of budget planning and management within their organizations.



The course featured a blend of interactive discussions and presentations that covered various key topics, including the context of budgeting in management, types of budgeting approaches, preparing budgets and monitoring and controlling budgets.

Participants engaged in presentations that challenged them to analyze real-world scenarios, fostering a deeper understanding of how effective budget management can drive organizational success.

Discussion on a lobster harvest strategy begins

With the FishPath process successfully completed for the lobster fishery in Seychelles, the Seychelles Fisheries Authority (SFA) is now working on creating a plan to manage the lobster population more effectively.

As part of the work, the SFA in collaboration with the FishPath team through a grant from the International Climate Initiative, have held a workshop to involve local fishers in the decision-making process. The event brought together lobster fishers from Mahe, Praslin and La Digue, as well as other relevant stakeholders. Dr. Ameer Ibrahim, a Seychellois fisheries specialist and consultant, emphasized that managing the lobster population involves more than just restricting fishing. It also considers economic, social, and biological factors to ensure sustainable fishing practices.

At the workshop, lobster fishers had the chance to discuss their experiences and concerns, which included a significant decline in lobster populations and ongoing issues with illegal, unregulated, and unreported fishing. Many participants expressed their support for implementing a harvest strategy to ensure sustainable lobster fishing practices.

The team is still in the early stages of developing the harvest strategy and will be analyzing the information gathered from the FishPath process to create an effective plan for managing the lobster fishery.
